# MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is made on this date 01stof month October Year 2016

#### Between

M/s. Evangeline Booth Hospital having its registered office at Opposite Post Office, Ahmednagar, Maharashtra 414001 and represented by Dr. Uzagare Medical Director, which expression shall, where the context so require or admits, be deemed to include its executor, successors, administrators and assigns (hereinafter referred to as "Hospital")

#### AND

Bhaskar Pandurang Hivale Education Society, Ahmednagar registered under the Society's Registration Act 1860 and the Public Trust Act 1950 established in 1969 and having its office at Ahmednagar College Campus Post Box No 21, Station Road, Ahmednagar, Maharashtra 414001 and represented by its Secretary, Mr. Vishal P Barnabas which expression shall where the context so requires or admits, be deemed to include its executors, successors, administrators and assigns (hereafter referred to as "Society").

Whereas the First Party is running a Hospital at Ahmednagar, with all medical facilities and hereby signs a Memorandum of Understanding with the Second Party and under which makes special arrangements/tie up with the Second Party, as the Most Preferred Educational Institution Client (MPEIC) to provide medical facilities at the Hospital of the First Party for its valid students, employees and employee's family members pertains to Ahmednagar College, Institute of Management Studies Career Development and Research (IMSCDR) and CSRD – Institute of Social Work and Research (All Units of BPHE Society) as per the terms and conditions enumerated below:

- 01. The MoU witness and agreed by and between the parties is as follows:
  - a) The Hospital has agreed to provide Ambulance facility in case of emergency.
  - b) Any revision in the charges will immediately be brought to the notice of the authorities of the Society.
  - c) The Society and the Hospital will have no objection in using their name and other relevant information in advertisement, website, promotion literature etc.
  - d) All services provided by the Hospital shall be according to the parameters and clinical protocols.

- e) The Society will not interfere in the treatment and medical services provided by the Hospital to the students and employees of the College / Institutes, unless it is required.
- 02. The Hospital will not disclose or share any information about the students, employees or the business activities of the Society with outsider or other agencies involved in similar business.
- 03. The MoU shall come into force with effect from 01st October 2016 and will remain in force until terminated by either party by giving the other party not less than One month / Three months notice in writing.
- 04. All the disputes or differences arising out of it and connected with the MoU shall be referred to the arbitrator in accordance with the Indian Arbitration Act. The courts in Ahmednagar shall only have jurisdiction to the exclusion of all other courts.
- 05. Under this MoU, the First Party/ Hospital shall admit duly authorized student and employee of the College / Institutes of the Society without any advance deposit to be paid at the time of admission as an Indoor Patient (IP) and provide 20% discount to students & Employees on IP/ OPD Consultation, investigation, accommodation, Medicine & Medical Checkup charges.
- 06. The Society will refer the patient with the appropriate document as mentioned in the Annexure-1 attached herewith for getting treatment as an indoor patient, emergency cases, etc. in the Hospital of First Party.
- 07. The Hospital shall notify and update the Society, by submitting list of Mediclaim Insurance Companies, with whom the Hospital has tie up for cashless medical/ hospitalization facility. The Society shall inform/ publicize such details to the students, parents, employees and encourage them to get policy from such Insurance Companies.
- 08. In case of exigency, or holidays, or Sundays or night hours, the Hospital will admit the patient upon telephonic instruction from any of the authorized person/officials mentioned in the Annexure- I of the Society, so as to proceed for the handling of exigency forth with without delay. The appropriate document in such cases would be deposited with the Hospital by the concerned from the Society within 48 hours of admission.
- 09. That the terms & conditions of this MOU will be reviewed after every 12 months or earlier in case of special circumstances.

## 10. Termination:

- a) Either party may terminate the agreement by issuing a one month's prior notice in writing to the other party.
- b) In case of termination by the Hospital, the hospital shall remain responsible for all assignments being attended to by hospital at the time of termination of the agreement.
- c) In case of termination by the Society, the competent authorities of the Society shall assist for clearance of all outstanding payment of the patients at the time of termination notice.
